Steve Day joined the Marine Corps in 1974 and, following his initial training, was commissioned in June 1975. He attended law school at the University of Denver and graduated in 1978. Following additional military training at Quantico, Virginia and Newport, Rhode Island, Mr. Day was ordered to the 1st Force Service Support Group at Camp Pendleton, California for duty. During the next four years, Mr. Day served at various times as a defense counsel, trial counsel, review officer, and Military Police company commander.

In 1983, Mr. Day was assigned to the 3rd Force Service Support Group in Okinawa, Japan where he served as a trial counsel and Deputy Staff Judge Advocate. In 1997, Mr. Day was selected for promotion to the grade of colonel and was transferred to Camp Pendleton, CA for duty as the Circuit Military Judge of the Sierra Judicial Circuit. In June 1999, Mr. Day was transferred to MCAS Cherry Point for duty as the Staff Judge Advocate of the 2nd Marine Aircraft Wing, with additional duty as the Director of the MCAS Cherry Point Joint Law Center. In 2002, Mr. Day was assigned duties as a military judge with the Piedmont Judicial Circuit at Camp Lejeune. Upon his return from this deployment, Mr. Day assumed duties as the Circuit Military Judge of the Piedmont Judicial Circuit.
